

Piankatank Shores Speedbump Process

In our community, safety is of upmost importance to all of us. As a reminder, if you witness someone driving recklessly including speeding, the first course of action is to report it to local law enforcement. To request a speedbump, email this form to PiankatankShoresCommunity@gmail.com or send this form to PO Box 146, Hartfield, VA 23071.

- 1. A speedbump installation requires PSCA Board authorization.
- 2. Lot owners use this form to request a speedbump to the PSCA Board with the understanding that the materials, installation, maintenance of the speedbump and signage are at the lot owner's expense.
- 3. The PSCA Board will review the request and confirm or deny the request within 30 days.
- 4. The speedbump cannot be within 300 feet from another approved speedbump or dip.
- 5. The PSCA Board has the authority to approve or deny the request of speedbumps on all PSCA-owned roadways.
- 6. After installation, the PSCA has the authority to demand removal or to remove speedbumps regardless of prior approval.

Below are directions to the lot owner once approved by the board:

- 1. The speedbump cannot be within 300 feet from another approved speedbump or dip.
- 2. The speedbumps must be separated in a manner to allow golf carts to pass through without having to travel over them. The speedbump shall maintain a minimum of 5 feet clearance in the middle of the speedbump.
- 3. Authorized speedbumps must be installed by property owners at their own liability and expense and shall display proper warning signage. The warning sign to be installed 25 feet prior to the speedbump in both directions.
- 4. To maintain uniformity, both the speedbump and the warning sign should appear as the example below.

5. The speedbumps must be removed by the property owner prior to the annual spring road maintenance projects. Re-installation of the speedbumps shall be the owner's responsibility. If the speedbump is not removed when requested by PSCA, the speedbump will become the property of PSCA.
